
Legal Notice

Resolution of the Board of Directors Of the Lower Colorado River Authority

Naming the Arbuckle Reservoir

Whereas, J. Scott Arbuckle, during his service as a member of the Lower Colorado River Authority Board of Directors from April 7, 2011, to December 6, 2015, representing Wharton County, showed extraordinary vision and leadership in working toward building a new water supply reservoir to benefit the entire lower Colorado River basin; and

Whereas, the new, off-channel reservoir, under construction near Lane City in Wharton County, will be the first significant new water supply reservoir developed in the lower Colorado River basin in decades. It could add up to 90,000 acre-feet of water per year to the region's supply, being the first project that will allow LCRA to capture and store significant amounts of water downstream of the Highland Lakes; and

Whereas, the new reservoir will benefit the entire basin by helping reduce the amount of water otherwise required to be released from the Highland Lakes to serve downstream demands, including industrial and agricultural customers. It also will improve the reliability of water for agriculture; and

Whereas, Director Arbuckle's energy, enthusiasm and unwavering dedication to working with others to find solutions to pressing challenges were instrumental in making the reservoir a reality. While others are talking about new water supplies, LCRA is building them, thanks in large part to Director Arbuckle; and

Whereas, the full Board greatly appreciates Director Arbuckle and thanks him for his spirit, hard work, and devotion to LCRA and the Texans we serve. He consistently demonstrates wisdom and integrity, along with his great sense of humor. Anything in which Director Arbuckle was involved during his tenure on the Board was better for it. As Board Chair Timothy Timmerman said, he "hardly met a man who has a bigger heart. Anything he ever touched ... he gave it his all. And Scott Arbuckle has a lot of all. He is truly loved";

Now, Therefore, Be It Resolved that the LCRA Board of Directors, in honor of Director Arbuckle, with heartfelt gratitude for his exceptional service to LCRA and the people of Texas, names the Lower Colorado River Authority's water supply reservoir in Wharton County the Arbuckle Reservoir.
