#### **OFFICIAL RULES**

Terms, Conditions and Rules (the "Rules") for Sponsor's "Be LakeWise" 2023 Online Sweepstakes (the "Promotion")

This Promotion is governed by the laws of the State of Texas, and all claims must be resolved in the federal or state courts located in Texas. You are not authorized to participate in the Promotion if you are not located within the United States.

- 2. Eligibility. Entrant must be a legal resident of the United States and at least 18 years of age as of 5/22/2023. # **Definitions**

When used in this Privacy Policy, the following terms have the following meanings:

- "LCRA", "We", "Us", "Our", and "Ours" mean and refer to the Lower Colorado River Authority, a conservation and reclamation district of the State of Texas created pursuant to Article XVI, Section 59, of the Texas Constitution.
- "Sweepstakes" means LCRA's 2023 Be LakeWise online promotion.
- "Terms" means collectively the Sweepstakes Official Rules and the Privacy Policy set out below.
- "You", "Your", and "Yours" mean and refer to the person accessing the Sweepstakes.

## Introduction

LCRA respects Your privacy and is committed to protecting it through our compliance with this Privacy Policy. This Privacy Policy describes the types of information we may collect from You or that You may provide when You visit the Sweepstakes and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Privacy Policy applies to information we collect:

Via the Sweepstakes;

In email, text, and other electronic messages between You and LCRA;

It does not apply to information collected by:

Us offline or through any other means, including on any other website operated by or on behalf of LCRA; or

Any third party, including through any application or content that may link to or be accessible from the Sweepstakes.

Please read this Privacy Policy carefully to understand our policies and practices regarding Your information and how we will treat it. If You do not agree with our policies and practices, Your choice is not to access the Sweepstakes. By accessing or entering the Sweepstakes, You agree to this Privacy Policy. This Privacy Policy may change from time to time. Your entry into the Sweepstakes after we make changes is deemed to be acceptance of those changes, so please check the Privacy Policy prior to entry.

# Information We Collect About You and How We Collect It

We collect several types of information from and about users of the Sweepstakes, including information: By which You may be personally identified, such as name, postal address, e-mail address, telephone number, social security number or federal tax ID number ("**personal information**");

That is about You individually, such as information entered or initiated by You through the Sweepstakes;

We collect this information:

Directly from You when You provide it to us; and

# Information You Provide to Us

Records and copies of Your correspondence (including email addresses), if You contact us; and

## Information We Collect Through Automatic Data Collection Technologies

As You navigate through and interact with the Sweepstakes, we may use automatic data collection technologies to collect certain information about Your equipment, browsing actions, and patterns, including:

Details of Your visits to the Sweepstakes, including traffic data, location data, logs, and other communication data and the resources that You access and use in the Sweepstakes; and Information about Your computer and internet connection, including Your IP address, operating system, and browser type.

The technologies we use for this automatic data collection may include cookies (or browser cookies). A cookie is a small file placed on the hard drive of Your computer. You may refuse to accept browser cookies by activating the appropriate setting on Your browser. However, if You select this setting You may be unable to access certain parts of the Sweepstakes. Unless You have adjusted Your browser setting so that it will refuse cookies, our system will issue cookies when You direct Your browser to the Sweepstakes.

# Third-Party Use of Cookies and Other Tracking Technologies

Some content or applications through which the Sweepstakes is provided may be served by third-parties, including advertisers, ad networks and servers, content providers, and application providers. These third parties may use cookies alone or in conjunction with web beacons or other tracking technologies to collect information about You when You use the Sweepstakes. The information they collect may be associated with Your personal information or they may collect information, including personal information, about Your online activities over time and across different websites and other online services. They may use this information to provide You with interest-based (behavioral) advertising or other targeted content.

We do not control these third parties' tracking technologies or how they may be used.

# How We Use Your Information

We use information that we collect about You or that You provide to us, including any personal information:

To present the Sweepstakes and its contents to You;

To provide You with information and services that You request from us;

To fulfill any other purpose for which You provide it;

To provide You with notices about Your entry into the Sweepstakes;

To carry out our obligations and enforce our rights arising out of the Terms;

To notify You about changes to the Sweepstakes or results of the Sweepstakes;

In any other way we may describe when You provide the information; and

For any other purpose with Your consent.

# **Disclosure of Your Information**

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose personal information that we collect or You provide as described in this Privacy Policy:

To contractors, service providers, and other third parties we use to support our business and operations;

To fulfill the purpose for which You provide it;

For any other purpose disclosed by us when You provide the information; or

With Your consent.

We may also disclose Your personal information:

To comply with any court order, law, or legal process, including to respond to any government or

regulatory request;

To enforce or apply any applicable provisions of the Terms;

If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of LCRA, our customers, or others.

You acknowledge that LCRA and its affiliates are subject to certain statutory obligations regarding the retention, disclosure, and public availability of information in their possession, custody or control, including but not limited to the Texas Local Government Records Act (ch. 201, Texas Local Government Code), the Texas Open Meetings Act (ch. 551, Texas Government Code), and the Texas Public Information Act (ch. 552, Texas Government Code). Nothing in this Privacy Policy is intended or may be construed to limit or prevent compliance with such obligations by LCRA or its affiliates.

We do not control third parties' collection or use of Your information.

## Data Security

The safety and security of Your information depends on You. Unfortunately, the transmission of information via the internet is not completely secure. Although we do our best to protect Your personal information, we cannot guarantee the security of Your personal information transmitted to or through the Sweepstakes. Any transmission of personal information is at Your own risk. We are not responsible for circumvention of any privacy settings or security measures contained in the Sweepstakes.
