Exhibit B.— Description of Use

Exhibit C.— Demand Schedule

A demand or use schedule that estimates your annual water usage, and any increases to it over time, of the water to be supplied under the proposed contract. This schedule will include a description and/or calculations showing how you determined the amount of water requested in this application.

Exhibit D.— Water Conservation Plan

A document outlining water conservation measures, as detailed in the Water Conservation Plan rules, the customer will follow. A sample plan is available.

Exhibit E.— Map
