

# PROTOCOLS FOR PUBLIC COMMUNICATION AT BOARD AND COMMITTEE MEETINGS Approved by the LCRA Board of Directors on Dec. 11, 2018

- 1. Oral Presentations on Issues Under LCRA's Jurisdiction. Any person wishing to make an oral presentation at a Board meeting on any matter under LCRA's jurisdiction must complete a registration form that indicates the agenda item or other topic on which they wish to comment, along with the speaker's name, address and other relevant information. Any person making an oral presentation to the Board may distribute related materials to the Board at the meeting.
- **2. Time Allocation**. The presiding officer may limit the length of time for each speaker. Speakers may not trade or donate time to other speakers without permission from the presiding officer, and repetitive testimony shall be minimized.
- **3. Rules of Decorum**. Speakers and members of the audience must avoid disruptive behavior that interferes with the orderly conduct of a public meeting. Placards, banners, and hand-held signs are not allowed in Board or committee meetings, and speakers and members of the audience must avoid personal affronts, profanity, booing, excessive noise, and other disruptive conduct. The presiding officer may direct that anyone who disrupts a meeting be removed from the room.
- **4. Recording**. Any person making an audio or video recording of all or any part of a Board meeting must do so in a manner that is not disruptive to the meeting. During a meeting, members of the public must remain in or behind the public seating area and are not permitted to record from any other area of the meeting room.
- **5. Committee Meetings**. The protocols outlined in 1-4 above also apply to members of the public wishing to address any LCRA Board committee whose membership comprises the entirety of the LCRA Board on matters within the scope of each of those committees.

# MINUTES OF THE MEETING OF THE WATER OPERATIONS COMMITTEE OF THE BOARD OF DIRECTORS OF THE LOWER COLORADO RIVER AUTHORITY

Pursuant to notice posted in accordance with the Texas Open Meetings Act, the Water Operations Committee (committee) of the Board of Directors (Board) of the Lower Colorado River Authority (LCRA) convened in a meeting at 10 a.m. Tuesday, Aug. 16, 2022, in the Board Room of the Hancock Building, at the principal office of LCRA, 3700 Lake Austin Blvd., Austin, Travis County, Texas. The meeting was open to the public, and the following committee members were present, constituting a quorum:

The committee heard public comments [Agenda Item 1]. Cindy Smiley, an attorney representing the Central Texas Water Coalition, commented on the posted agenda and notice for this meeting, and she expressed concerns about the need to initiate an update of LCRA's Water Management Plan.

Bob Leonard, owner of West Beach Marina on Lake Travis, commented on proposed changes to the Highland Lakes Marina Ordinance regarding enclosing unencapsulated floats.

<u>22-03</u> Upon motion by Vice Chair Crane, seconded by Director Whitten, the committee unanimously approved the minutes of its last meeting, held May 17, 2022, as presented.

Vice President of Water Operations Kelly Payne presented an update on basin conditions. Executive Vice President of Water John B. Hofmann provided an update on water supply conditions and status, and discussed how the Water Management Plan functions.

Director of Strategic Water Initiatives Lauren Graber presented a summary of proposed amendments to the Highland Lakes Marina Ordinance. She also noted the agenda item regarding a temporary moratorium for new applications for community marinas on the Highland Lakes pursuant to the ordinance [which appeared on the Aug. 17 LCRA Board meeting agenda].

There being no further business to come before the committee, the meeting was adjourned at 10:51 a.m.
