

Highland Lakes Marina Ordinance

- Originally established in 1984
- Last updated in 2011
- 147 permitted marinas on the Highland Lakes



Activities Since our Last Update

- Completed an overhaul of the ordinance
- Updated the fee schedule
- Posted proposed updates for review and comment in March 2023
- Held a public comment meeting on March 15
- Evaluated public comments
- Redrafted the proposed ordinance and fee schedule
- Prepared recommendations for Board consideration

Summary of Proposed Amendments

- Revise community marina regulations
- Replace unencapsulated flotation material
- Update fee schedule
- Update processes related to permit applications and amendments, public engagement, and appeals
- Revise/exempt certain location, configuration and setback requirements
- Update definitions, including for residential docks
- Increase minimum limits of liability insurance for marinas
- Reformat ordinance

Summary of Comments Received

- Community marina regulations
 - Too restrictive on existing community marinas
- Encapsulated flotation material
 - Timeline to replace is too short
- Updated fee schedule
 - Proposed increase too soon
- Other comments

Summary of Proposed Amendments

Community marinas

- No new community marinas will be permitted
- Existing community marinas allowed to expand as they could under the existing ordinance
- Subject to application and other fees
- Not subject to annual permit fees (no change from existing ordinance)

Summary of Proposed Amendments (Continued)

- Replacement of unencapsulated flotation
 - Establish a two-year timeline for replacement
 - Allow for the execution of an unencapsulated flotation replacement plan
 - Require replacement of flotation material that is:
 - More than 25% degraded
 - Not providing enough buoyancy

Summary of Proposed Amendments (Continued)

Annual permit fees

- Fees will increase from \$0.08 per square-foot to \$0.14 per sq-ft for the first 10,000 sq-ft
- Fees will increase from \$0.23 per sq-ft to \$0.38 per sq-ft for square footage greater than 10,000 sq-ft
- Fees will be phased in on the following schedule:
 - Half of the rate increase beginning in January 2024
 - Remainder of the rate increase beginning in January 2025
- Residential and community marinas are not subject to annual permit fees

Summary of Proposed Amendments (Continued)

- Other changes related to fees
 - Charge marinas the same permit application minimum filing fee
 - Charge residential and community marinas application and other fees (not subject to annual permit fees)
 - Separate the fee schedule from the ordinance
 - Update refund information to standard used by other water regulatory programs

HLMO Rate Development

- Develop a methodology for assigning annual budget to three primary programs
 - Highland Lakes Marina Ordinance
 - Residential Dock Safety Standards
 - Buoy and navigation management
- Develop rates that recover the full cost of service of the HLMO program
 - Current rates recover only a portion of program costs
 - Remainder is supplemented by other LCRA funds

HLMO Rate Development (Continued)

- Used fiscal year 2026 as the test year for computing the rate
 - Due to the step-in recommendation for the rates, FY 2026 is the first year the full rate will be in place
- Cost to recover includes
 - FY 2026 budget for the marina program
 - One-third of FY 2026 budget for buoy and navigation management program

and public boat ramps


 Buoy and navigational management provide navigation and safety aids to all lake users

New Rate Impacts

- Rate increase phased in between January 2024 and January 2025
- Use FY 2026 to develop the rate
- FY 2026 will be the first LCRA fiscal year with the new rate
